How We Prioritize Our Work

Priority 1

- Structure is a Single Family Dwelling, Owner Occupied
- Damage Level is assessed as "Major" or "Minor"
- No or insufficient Insurance coverage
- Occupants have age, mobility or medical issues, especially breathing and work is beyond owner's capability to do.
- Mold is present at Heavy, Moderate or Mild level and growing, or contents are soaked and will develop mold imminently.

Priority 2

- Structure is a Single Family Dwelling, Owner occupied
- Damage level is "Major" or "Minor"
- No or insufficient Insurance coverage
- Occupants have no health or mobility Issues
- Mold is present at Heavy, Moderate or Mild level and growing, or contents are soaked and will develop mold imminently.

Priority 3

- Structure is a Single Family Dwelling, Owner occupied
- Damage Level is assessed as "Minor"
- No or insufficient Insurance coverage
- Occupants have no health or mobility Issues

Who are we?

The Southern Baptist Disaster Relief network, which includes more than 83,000 trained volunteers and 2,000 mobile units, is the third largest disaster relief volunteer organization in the U.S.A. It is coordinated nationally by the North American Mission Board in cooperation with state conventions across America and now with the Canadian National Baptist Convention.

Disaster relief units (trailers) are owned and staffed by local Southern Baptist churches, regional Associations and by state Baptist Conventions. Volunteer teams respond to disasters within their own state (in our case any of the six states of New England) and work cooperatively with other states in larger emergencies.

D.R. in New England has been alive since 2000 and now have about eight mobile units with about 200 volunteers in six states. They are trained and prepared in chaplaincy, assessment, feeding, shower/laundry, mud-out and chain saw recovery.

Mud-Out Services We Provide

A. Determine that a dwelling is recoverable and can be made safe enough for Disaster Relief Teams to perform clean-up and Recovery activities.

- **B. Determine** that standard Flood recovery activities can provide substantial assistance to the home-owner in helping to return the dwelling to a condition ready for subsequent re-building and safe occupancy.
 - 1. Perform One or more/all of the following actions which constitute the Standard Flood Recovery "Mud-Out" activities performed by SBC Disaster Relief Teams:
 - · Removal of residual mud and water.
 - Carry-out of unsalvageable damaged property to designated curbside pickup areas or dumpsters.
 - Tear-out of damaged building materials such as carpeting, pads, sheetrock, sub-flooring, etc.
 - Power-washing of damaged/soiled areas
 - Sanitation (by bleaching/washing) and mop-up of affected structural areas to permit subsequent air-out and drying (average 6 weeks of drying needed) prior to re-build.
 - **2. Scope of Work**. A job order or request and the actions of the Mud-out team ready

for future mold growth— a job order or request <u>does not</u> include the actual rebuilding which must occur at a later date (after adequate drying of the structure)!!

How Does a Homeowner Qualify?



The Following Conditions **QUALIFY** an owner/structure for SBC Disaster Relief Job Order Assignment/approval:

- The structure/property must be a single family dwelling, owner occupied, in a recognized/declared/certified flood damaged disaster area.
- The owner (or authorized representative)
 must make arrangements to be present for
 job assessment and for interaction with the
 Team Leader during job work activity.
- 3. The owner (or authorized representative) must complete a "Property Owner Job Order Approval" form and submit it through the appropriate community/city/ state/government agency for certification and subsequent prioritization and scheduling. (Scheduling priority is based on need rather than first-come-first serve).



4. Property owner must coordinate with local agencies and authorities for removal of debris from curbside or with a dumpster.
